Official Contest Rules

1. ELIGIBILITY: NO PURCHASE NECESSARY. Open only to Canadian residents 19 years of age or older, void where prohibited or restricted by law, regulation, rule or otherwise. Contest begins at 12:01 a.m. EST on Friday April 16, 2010 and ends at 11:59 p.m. EST on Tuesday August 31, 2010. All entrants must have valid travel documentation and a recognized credit card.

Employees and immediate family members (and/or persons domiciled with) of Jet Set Travel, the prize sponsors and any employees or members of their affiliated companies are not eligible.

2. DEADLINES: The contest starts at 12:01 a.m. EST on Friday April 16, 2010 with a final submission deadline of Tuesday August 31, 2010 at 11:59 p.m. Eastern Standard Time (the "Contest Period").
